ADDITIONAL SERVICES

- * A minimum fee of \$50.00 shall apply for each additional plan review re-submission or for incomplete or denied plans.
- * Inspections only, re-inspections or additional inspections shall be invoiced at \$45.00 each.
- * An additional minimum fee of \$60.00 shall apply for a Certificate of Completion/Certificate of Occupancy inspection in municipalities where CodeMaster serves as Building Code Official and prior inspections have been conducted by another inspection agency.
- * Consultation and or attendance at meetings with applicants, Township Officials or Staff, Building Code Board of Appeal meetings or special site visits or meetings shall be invoiced at \$60.00 per hour.
- * Administrative Costs - Minimum 1 hour @ \$30/hour plus fraction thereof.
- * CodeMaster may require building plans and specifications to be stamped and/or sealed by a design professional licensed in the Commonwealth of Pennsylvania. This would typically apply to non-conventional type construction or structures.

COMMERCIAL CONSTRUCTION NOTES

- Permit fees are due at the time of application. Permits will not be reviewed until the appropriate fees have been paid.
- Square footage will be verified, adjustments noted, and cost adjusted accordingly during plan review. Any subsequent fees shall be satisfied prior to release of a Building Permit.
- All commercial building plans and specifications involving a structural change, a change in the means of egress, or where an individual has been compensated must be stamped and/or sealed by design professional licensed in the Commonwealth of Pennsylvania.
- All components shall be submitted in their entirety. Submission of incomplete packages will delay review.
- A minimum fee of \$250 shall apply to each additional plan review re-submission or for incomplete or denied plans. This fee must be paid at the time of re-submission.
- Inspections only, re-inspections or additional inspections shall be invoiced at \$60.00 per hour.
- An additional minimum fee of \$60.00 shall apply for a Certificate of Completion/Certificate of Occupancy inspection in municipalities where CodeMaster serves as Building Code Official and prior inspections have been conducted by another inspection agency.
- Any re-inspection fees are **payable to the Township's Third Party Agency** and must be satisfied prior to release of the Occupancy Permit.
- Administrative Costs - Minimum 1 hour @ \$30/hour plus fraction thereof.
- A fee of **\$60.00 per hour** will be charged for consultation and/or attendance at meetings with applicants, Township Officials or Staff, Building Code Board of Appeals or special site visits or meetings. All additional fees must be satisfied prior to release of permit(s).
